# WILDWATER RESCUE SYSTEM IN THE REPUBLIC OF SLOVENIA (RS)

## INTERPRETATION OF TERMS AND ACRONYMS



NATIONAL PROGRAM IN THE REPUBLIC OF SLOVENIA: WILD WATER RESCUER - PROGRAM C (license C)

A valid C license is required when performing guide activity on wild waters in the Republic of Slovenia (rafting, canyoning, kayaking, etc.)

Acronym: **WWR-C**



ADMINISTRATION OF THE RS FOR CIVIL PROTECTION AND DISASTER RELIEF- URSZR

- The umbrella governmental organization in the Republic of Slovenia which is responsible for regulating the field of water rescue
- Slovenian acronym: **URSZR** (URSZR operates within the Ministry of Defense of the Republic of Slovenia)



DROWNING PREVENTION INSTITUTE - ZVU

- Official authorized provider of training for wild water rescuers (WWR-C) in the Republic of Slovenia
- Slovenian acronym: **ZVU**



SLOVENIAN RED CROSS - SRC

- An official organization that conducts first aid training in the Republic of Slovenia and issues certificates of competence for water rescuers (lifeguards)
- Slovenian acronym: **RKS**



DOCTOR SPECIALIST OF OCCUPATIONAL, TRAFFIC AND SPORTS MEDICINE

It conducts examinations and issues medical certificates for water rescuers (lifeguards)

SUCCESSFULLY PASS THE WWR-C EXAM

The exam is conducted by the URSZR

**It is necessary to register for the exam at the same time as registering for the WWR-C training!**

**BEFORE THE APPLICATION FOR WWR-C TRAINING AND WWR-C EXAM, THE CANDIDATE MUST OBTAIN:**

**MEDICAL CERTIFICATE FOR WATER RESCUERS**

The examination is performed by a doctor specialist of occupational, traffic and sports medicine.

**LICENSE ISSURANCE (license issued by URSZR)**

The license is issued to the candidate when he meets all the conditions and submits all the necessary documentation to the URSZR. The license is valid for 3 years and is counted from the day of successfully passing the WWR-C exam.

**DOCUMENTATION:**

1. certificate of appropriate education (at least vocational secondary school - IV. level);
2. a digital photo of the candidate (like for documents) for the card;
3. SRC certificate of FA for water rescuers (lifeguards);
4. medical certificate for water rescuers (lifeguards)

# WHAT YOU NEED TO KNOW TO APPLY FOR ZVU-WWR-C TRAINING

(Simultaneously with the application for ZVU-WWR-C training, it is necessary to apply for the WWR-C exam at the URSZR as well.)

## APPLICATION CONDITIONS FOR THE TRAINING:

- completed age 18 years over 18 years of age
- medical certificate for water rescuers, issued by a specialist in transport and sports medicine in the Republic of Slovenia

## CONDITIONS FOR PARTICIPATION AT THE TRAINING :

- personally signed Application Form
- personally signed Consent for the processing and use of personal data
- registration fee paid before the training
- successfully passed swimming test
- all mandatory personal equipment

## CONDITIONS for SUCCESSFUL COMPLETION OF THE TRAINING:

- 100% PRESENCE
- POSITIVE OVERALL EVALUATION OF DAILY EVALUATIONS

### Standard:

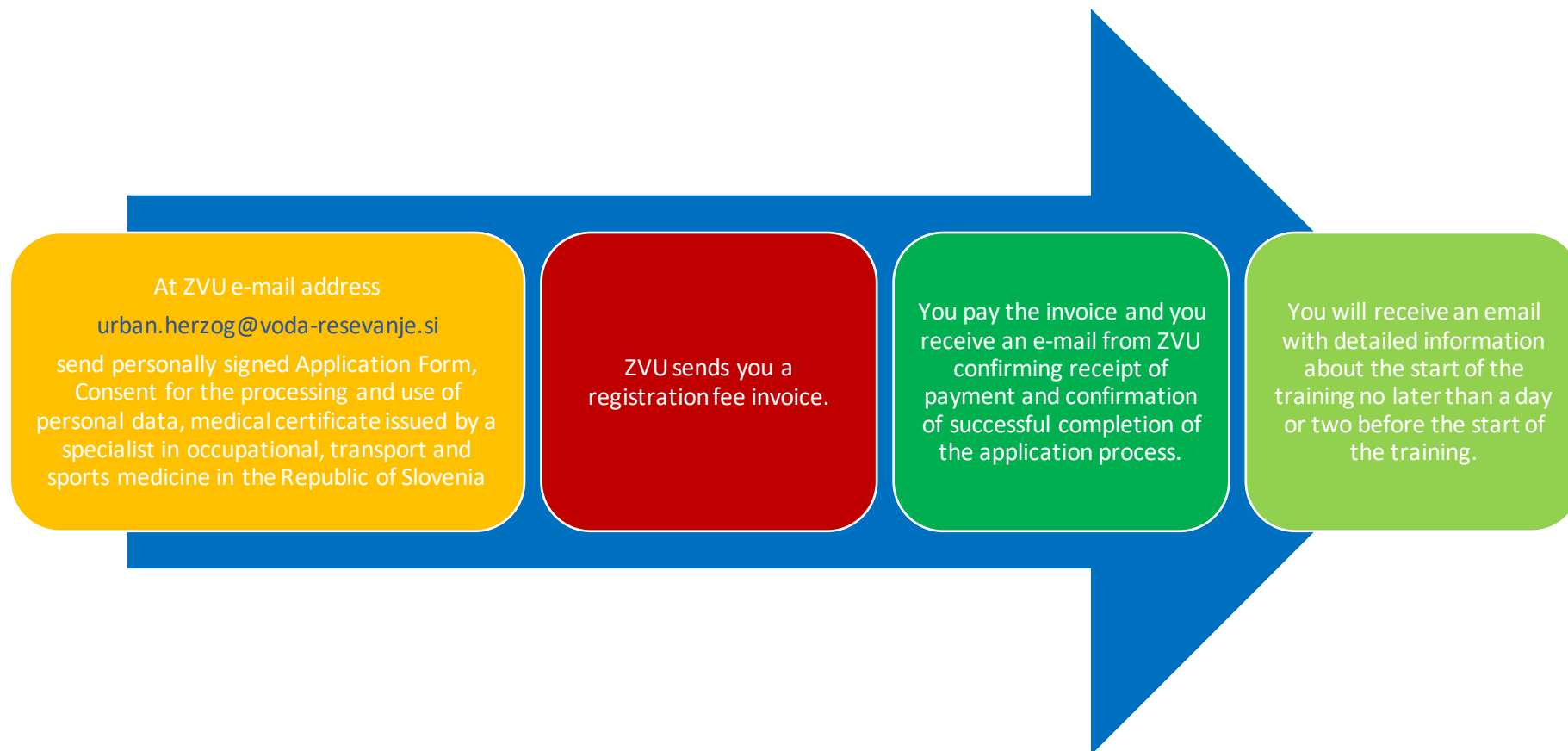
Swimming 60 s in full PPE for WWR and one current crossing in that time

You pay the exam costs after the exam, when the URSZR issues you an invoice.

You will receive the license when you have submitted all the required documents to the URSZR and settled your financial obligations.
